- * The minimum amount for a BD-RTGS payment in BDT is 1, 00,000.00 (Taka one hundred thousand). However, there is no minimum limit for foreign currency payments.
- * I/We hereby authorize MDB to carry out the BD-RTGS transaction as per details mentioned above.
- * I/We hereby agree that the aforesaid details including beneficiary bank, branch name & beneficiary account are correct.
- * I/We further acknowledge the MDB accepts no liability for any consequences arising out of erroneous details provided by me/us.
- * I/We agree that the credit will be affected solely on the beneficiary account number information and beneficiary name particulars will not be used for the same.
