## Terms and Conditions of RTGS (Real-Time Gross Settlement)

- A valid RTGS payment is final and irrevocable. Settlement will be final and unconditional at the moment that the settlement accounts of OB (originating/remitting bank) and RB (receiving bank) have been debited and credited.
- Value/Transaction Limit: The minimum amount for a RTGS in BDT is 100,000.00 (Taka one hundred thousand). However, there is no
  minimum limit for foreign currency payments and customs duty payment in local currency. There is no maximum limit for RTGS except
  system's field limit (17 digits). Bangladesh Bank may relax the limit for specific local currency payments like Tax, VAT.
- 3. I/We hereby authorize Midland Bank (MDB) to carry out the BD-RTGS transaction as per details mentioned above.
- 4. I/We hereby agree that the aforesaid details including beneficiary bank, branch name & beneficiary account are correct.
- 5. I/We further acknowledge the MDB accepts no liability for any consequences arising out of erroneous details provided by me/us.
- 6. I/We agree that the credit will be affected solely on the beneficiary account number information and beneficiary name particulars will not be used for the same.
- 7. I/We authorize the MDB to debit my/our account with the services charges with VAT as applicable for this transaction.
- 8. I/We further agree that requests submitted after the cut off time will be sent in next batch or next working day as applicable.
- 9. I/We hereby agree & understand that the BD-RTGS request is subject to the Bangladesh Bank regulations and guidelines governing the same.
- 10. I/We also agree and understand that the MDB shall not be liable for any loss of damage arising or resulting from delay in transmission delivery or non-delivery of Electronic message or any mistake, omission or error in transmission or delivery thereof or in deciphering the message form any cause whatsoever from its misinterpretation received or the action of the destination Bank or any act or even beyond control
- 11. I/We hereby indemnify the MDB and shall keep the MDB indemnified from time to time and at all times here after from any loss, claim, damage, cost, charge and expenses however caused or arising out of or in connection with the services offered by the MDB.
- 12. I/We agree and understand that in case the payee branch does not have BD-RTGS facility, the fund will be credited back to my/our account as when it is returned by originating bank to MDB.
